Equipment Hire Terms and Conditions

If you are organising an event which requires a range of catering equipment that you currently don't have, then we here at Kings Cater Hire can help. Our catering equipment hire services are highly competitive and flexible and we will work closely with you to create a package tailored to your needs.

Hire Charges and Cancellations

The hirer is fully responsible for all equipment hired from the time of delivery until all of the goods are returned and checked by our staff. This includes damages in transit, fire, theft, vandalism, breakages and any other losses.

Booking; a non returnable 50% deposit charge is requested along with all bookings to be submitted by e-mail or in writing along with a signed contract hire agreement.

At the time of booking full card details will be taken to secure the booking. The full balance will be required 14 days prior to delivery date (no delivery will be made of hire goods without full balance cleared) and deposits lost.

Goods not returned on the arrangement date will be charged an extra hire charge of 50% of 1 days hire per part/full day thereafter until goods are returned.

The hirer should ensure that the hire goods arrive in perfect condition and any problems noted on delivery and before returning check quantities and pack them in the same condition as received.

All hire goods should be returned clean. Failure to do this will incur further charges at 50% of the total hire charge or pay for cleaning charges.

Any losses, breakages or damaged equipment will be charged at full item replacement value at the time of booking.

Cancellation of equipment hire must be submitted in writing;

12-6 months prior to hire date deposit lost and no extra costs occur

6-3 months prior to hire date deposit lost with 50% of balance to pay

3 to hire date will incur full cost of hire.

Delivery and Collection

Delivery and collection charges will be given on request. Deliveries will be made by prior arrangement. Times are given only approximately. No responsibility can be accepted for goods not arriving on time owing to adverse road/weather conditions or for any reason beyond our control.

Should our transport be held up on site for an unreasonable period of time, a time charge of £20.00 per hour after the first half hour will be implemented.

Delivery and collections are quoted for a door to door service by a single driver unless otherwise agreed at booking. (an extra charge will occur for more help hand) please ask for a quote. Please ensure that you have enough manual assistance with the moving/siteing and removal of equipment especially at difficult venues such as; Marquees, office premises, large halls, and locations off the ground floor level (stairs only). Where delivery entails our staff moving goods to specific areas and/or having to reassemble equipment after use and extra time is involved, additional charges will be made. We take no responsibility for any damages made to property once in the hirers charge.

Hirers should ensure they or their representative are at the delivery address for delivery to ensure the checking off and signing for the delivery.

The hirer must be available to accept the delivered goods or collected goods at the address stated on the appointed date. If the hirer is not available the goods must be collected or returned to our unit by the hirer. Wasted journeys will incur another delivery/collection charge.

Goods not returned on the arranged date will be charged an extra hire charge of 50% of days hire rate per part/full day thereafter until goods are fully returned.
